# COVER THAT MATTERS\*

With Mercury Insurance Pleasure Craft Insurance you are covered whilst navigating up to 250nm off Australia and New Zealand.

Summary of Features	Benefits
<b>Section 1 – Cover for Your Boat</b>	
Insured components	Cover for your boat, motor, trailer, equipment and accessories, boat tender and personal effects when on the insured boat or tender. Your policy also includes overheating cover for motors following an external blockage of the cooling system.
Genuine parts	If we agree to repair your motor and are unable to fix the damaged part(s), we will replace the damaged part(s) with Mercury genuine parts.
Mercury replacement cover for new boats	If your boat is new when you first enter into a policy with us covering your boat and it becomes a total loss within the first 3 years, we will replace your boat with a new boat of the same make, model and series.
Validation options	You can choose between Agreed Value or Market Value, subject to our acceptance criteria. <ul style="list-style-type: none"> <li>• Agreed Value is the amount we agree upon as the value of the boat which we will pay you in the event of a total loss. It is valid until the next renewal date</li> <li>• Market Value is the amount we will pay in the event of a total loss where you have not taken the Agreed Value option. The amount payable in this case is determined by the sale value of the boat immediately prior to the claimed loss or damage taking into account the condition and location of the boat</li> </ul>
Fishing gear, water-ski and dive equipment and tools	\$1,500 per item, up to \$10,000 total (not in addition to sum insured).
Personal effects	\$1,500 per item, up to \$10,000 total (not in addition to sum insured). Includes clothing, shoes, waterproof gear, wetsuits, prescription and sunglasses, manchester, mobile phones, jewellery, watches, cameras, computers and personal electronic devices.
Emergency costs and salvage charges	Reasonable costs to minimise or prevent further loss following an insured event. Such costs are payable in addition to the sum insured subject to a cap equal to the sum insured value.
Land towing costs	Up to \$1,000 for land transit towing of your boat by trailer to the nearest repairer.

Liability to third parties including removal of wreck costs	Flexible cover up to \$20m for personal injury and property damage caused by you or a person operating the boat with your permission. You are also covered for your liability whilst operating another boat you are licenced to operate.
Legal costs and expenses	All legal costs and expenses incurred in defending any court proceedings which may arise in respect of any liability covered, subject to prior written agreement. Exclusions apply for legal costs and expenses relating to criminal, maritime or traffic proceedings.  Discharge, release or escape of substances: We will pay up to \$500,000 (incl. GST) for any one event including legal expenses.
<b>Section 3 – Personal Injury</b>	
Injury to the named insured	Up to \$50,000 plus \$5,000 funeral expenses.
